January 12, 2010 | 7:50 p.m.

At 7:50 p.m., a student reported that her vehicle was broken into. The complainant stated that she found the door open and unlocked. Nothing appeared to be missing. An officer responded and found the door locks intact and there were no signs of forced entry.
