### Significant Change in Education Requirements for Nursing Home Administrators in the State of Michigan

*The State of Michigan has changed the education requirements for licensed nursing home administrators beginning May 7, 2026. In addition to these pre-licensure courses offered by Madonna University, administrators will also need to be an RN (associate's trained or higher), OR have earned at least a bachelor's degree.*

*Examinations are administered by the National Association of Long-Term Care Administrator Boards (NAB).*

*Additional state licensure fees apply through Michigan's Licensing and Regulatory Affairs (LARA).*

*Madonna University offers optional exam prep workshops to support student success and career.*
