

Verification of 2016 Income Information for Parent Nontax Filers

Your 2018-2019 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. If there are differences, your FAFSA information may need to be corrected. If you have questions about verification, contact the Financial Aid Office as soon as possible so that your financial aid will not be delayed. Your financial aid eligibility cannot be determined, and financial aid will not be awarded or disbursed, until the verification process is complete.
